**Re:** FFY 2021 – 2025 revised local STP programming marks

On January 20, 2020 the Illinois Department of Transportation published circular letter 2020-02 that provided the Federal Fiscal Year (FFY) 2021 STP Local (STP-L) funding allotment for the CMAP region. Because of additional funds appropriated by Congress, the allotment is \$10,719,956 above the [estimate provided](#) in October 2019. The increase is only for FFY 2021, leaving FFY 2022 – 2025 unchanged.

The procedure used to develop the revised programming mark for FFY 2021 follows the process laid out in the [STP agreement](#). After deducting a portion of the funding for the Shared Fund, the remainder is distributed to the councils using a formula based on five performance measures. Per the agreement, the results of the formula were “smoothed” to prevent any council from receiving less than \$3 million in any year, and to prevent any council from receiving 10% more or less than their FFY 2017 mark in the first FFY of the agreement, which is FFY 21. The revised programming marks are shown in Table 1 below.
