The Kane County Division of Transportation is in need of professional services from a qualified engineering firm to provide Traffic Safety Engineering and Phase II Design Services.

Statements of Interest received will be used by County engineering staff to develop a short-list of three (3) firms. The County will then submit a Request for Proposal (RFP) and schedule interviews with the short-listed firms.

PROJECT DESCRIPTION/PRELIMINARY SCOPE OF SERVICES
KANE COUNTY HIGHWAY SAFETY IMPROVEMENT PROJECT

The selected Consultant will provide necessary traffic safety engineering and Phase II engineering services in order to deliver all necessary P.S. & E. documents for the construction and implementation of roadway safety improvements and crash countermeasures at the following Kane County Highway locations.

1. Fabyan Parkway (County Route #8) -Main Street to Kane/DuPage County Line
2. Hughes Road (County Route #26) –IL Route 47 to Fabyan Parkway
3. Orchard Road (County Route #83)-Jericho Road to I-88
4. Randall Road (County Route #34) – Orchard Road to Fabyan Parkway

Kane County has received approximately \$2,443,500 in Federal Highway Safety Improvement Program (HSIP) funds for this project.

Proposed roadway safety improvements and crash countermeasures for this project include the following:

- Various traffic signal improvements including improved traffic signal head placement for increased conspicuity and protected only left turn and or Flashing Yellow Arrow (FYA) displays.
- Dynamic/ Variable speed warning signs
- Rumble Strips and Rumble Stripes
- Modified pavement marking and signing
- Flashing Warning Beacons

The Consultant shall perform a safety analysis in accordance with methodologies and practices set forth in the latest edition of the ASSHTO Highway Safety Manual (HSM), which shall support all proposed improvements/countermeasures. Additional improvements/countermeasures may be recommended, which provides additional crash reduction as supported by the safety analysis and dependent on available funding. The final scope will be determined by the recommendations of the safety analysis and approved by staff.

Preparation of all contract documents shall be in accordance with applicable IDOT Bureau of Local Roads and Streets for Federal Aid Project; and County standards.

QUALIFICATIONS

Interested consultants should possess competency in the following areas of expertise:

- Traffic and highway safety engineering
- A project manager that possesses certification as a Professional Traffic Operations Engineer (PTOE) is desirable.
- ASSHTO Highway Safety Manual (HSM)
- Traffic Signal design (per IDOT Region/District One and Kane County standards)
- Pre-qualified for Phase II engineering with IDOT, District One, Region One
- Manual on Uniform Traffic Control Devices (MUTCD)
- ITE Traffic Control Devices Handbook

PROJECT DURATION

Contract duration shall begin upon the receipt of the notice to proceed from the County to the Consultant, which is anticipated in **mid 2013** with an anticipated project letting in **late 2013/early 2014**.
