

## PUBLIC NOTICE

The County of Kane intends to request approval of legislation by the Illinois General Assembly that will authorize the County of Kane to acquire the real property described herein below by eminent domain using "quick take" authority under the Illinois Code of Civil Procedure (see the Illinois Compiled Statutes: 735 ILCS 30/1-1-1 et. seq., and 735 ILCS 30/20-5-5 and 735 ILCS 30/25-5-5) for the Huntley Road at Galligan Road intersection improvement and for the Longmeadow Parkway Bridge Corridor improvement.

The County of Kane shall hold a public hearing on the question of the acquisition of the property described herein below by eminent domain using "quick take" authority in the Kane County Board Room at 719 South Batavia Avenue, Building "A" at 4:00 p.m. on January 19, 2017. The public is invited.
