The purpose of the meeting is to seek public comments on the proposed improvement for Montgomery Road located in the Village of Montgomery and the City of Aurora, extending from Briarcliff Road on the west to Hill Avenue on the east. The preliminary Preferred Alternative will address existing and future capacity, operational, and design standard deficiencies associated with this section of roadway. Included in this study was an in-depth review of the existing and future bicycle and pedestrian connectivity and associated impacts to the environment.

The public hearing will be conducted in an open house format, and interested persons may attend anytime between 4:00 PM and 7:00 PM. A continuous audio-visual presentation will provide an overview of the study and the preliminary Preferred Alternative. Attendees are encouraged to provide verbal or written testimony to a court reporter, which will be included as part of the public record. Attendees will have the opportunity to view preliminary construction drawings, exhibits, provide comments, and meet with KDOT and project study team representatives.

KDOT is also seeking public comments on the use of property from the Aurora Township Soccer Field (Aurora Township), Virgil Gilman Trail (Fox Valley Park District), Phillips Park Aquatic Center (Fox Valley Park District/City of Aurora), and Phillips Park Golf Course (City of Aurora) for the associated improvements to Montgomery Road which are protected by Section 4(f) of the U.S. Department of Transportation Act of 1966. KDOT intends to seek a de minimis impact finding from the Federal Highway Administration (FHWA) based on the project **not adversely affecting the features, attributes, or activities** qualifying the properties for protection under Section 4(f).
