RESOLUTION NO. 08 - 88

**ADOPTING A POLICY FOR RED LIGHT RUNNING
CAMERA ENFORCEMENT SYSTEMS**

WHEREAS, the County of Kane has experienced, through its Division of Transportation, significant interest in Red Light Running Camera Enforcement Systems by municipalities located in Kane County; and

WHEREAS, the County of Kane is empowered pursuant to the Illinois Compiled Statutes, (605 ILCS 5/5-413 and 605 ILCS 5/8-102) to regulate County highways and freeways; and

WHEREAS, Public Act 94-0795 provides that various units of government may establish an automated traffic law enforcement system that produces a recorded image of a motor vehicle entering an intersection against a red signal indication which image shall be a clear, recorded image of the vehicle and the vehicle's license plate; and

WHEREAS, the installation of Red Light Running Camera Systems may be established only in the counties of Cook, DuPage, Kane, Lake, Madison, McHenry, St. Clair and Will and in municipalities located within those counties; and


WHEREAS, it is deemed to be in the best interests of the citizens of Kane County and the general motoring public that Red Light Running Camera Enforcement Systems at those intersections or parts thereof under the jurisdiction of the County of Kane be regulated by the County.

NOW, THEREFORE, BE IT RESOLVED by the Kane County Board that the Policy for Red Light Running (RLR) Camera Enforcement Systems (a copy of which is on file with the Kane County Clerk's Office) is hereby adopted effective April 1, 2008.

BE IT FURTHER RESOLVED that effective April 1, 2008, the fee for the issuance, by the Kane County Division of Transportation, of a permit for a Red Light Running Camera Enforcement System located at an intersection on a highway under the jurisdiction of Kane County shall be \$450 with a yearly Permit Renewal Fee of \$100.
