## **2020 Bowes Road Resurfacing Program Kane County Section No. 20-00521-01-RS**

Construction for the Bowes Road Resurfacing program is scheduled to begin the week of **Monday, July 20, 2020, weather permitting**. Construction will take place on Bowes Road, between Nesler Road and about 1,900 feet West of Randall Road, with working hours between **7:00 AM and 5:00 PM, Monday thru Saturday, requiring temporary daily lane closures and flaggers directing traffic for the safety of the workers and the travelling public**. The resurfacing process is part of our annual maintenance to increase the longevity of County roads. The program will consist of milling and resurfacing, ADA sidewalk work, curb and gutter removal and replacement work, and application of pavement markings. **This work is anticipated to take approximately three months to complete**, weather permitting. Listed below are the portions of roads to be resurfaced, with curb and gutter replacement noted.

The above-mentioned road will remain open during construction, but may include temporary daily lane closures and flaggers, primarily from 7:00 A.M. to 5:00 P.M. on Bowes Road. Motorists should expect long delays while traveling through the work areas and should add additional time to their commutes. Motorists are asked to reduce their speed, watch for construction workers and vehicles entering or leaving the site, obey flaggers and comply with traffic control devices within the work zone. Motorists may want to consider the use of alternate routes while this work is being completed.

A reminder – **it is illegal for drivers to talk on a cell phone while driving through a highway construction work zone.**

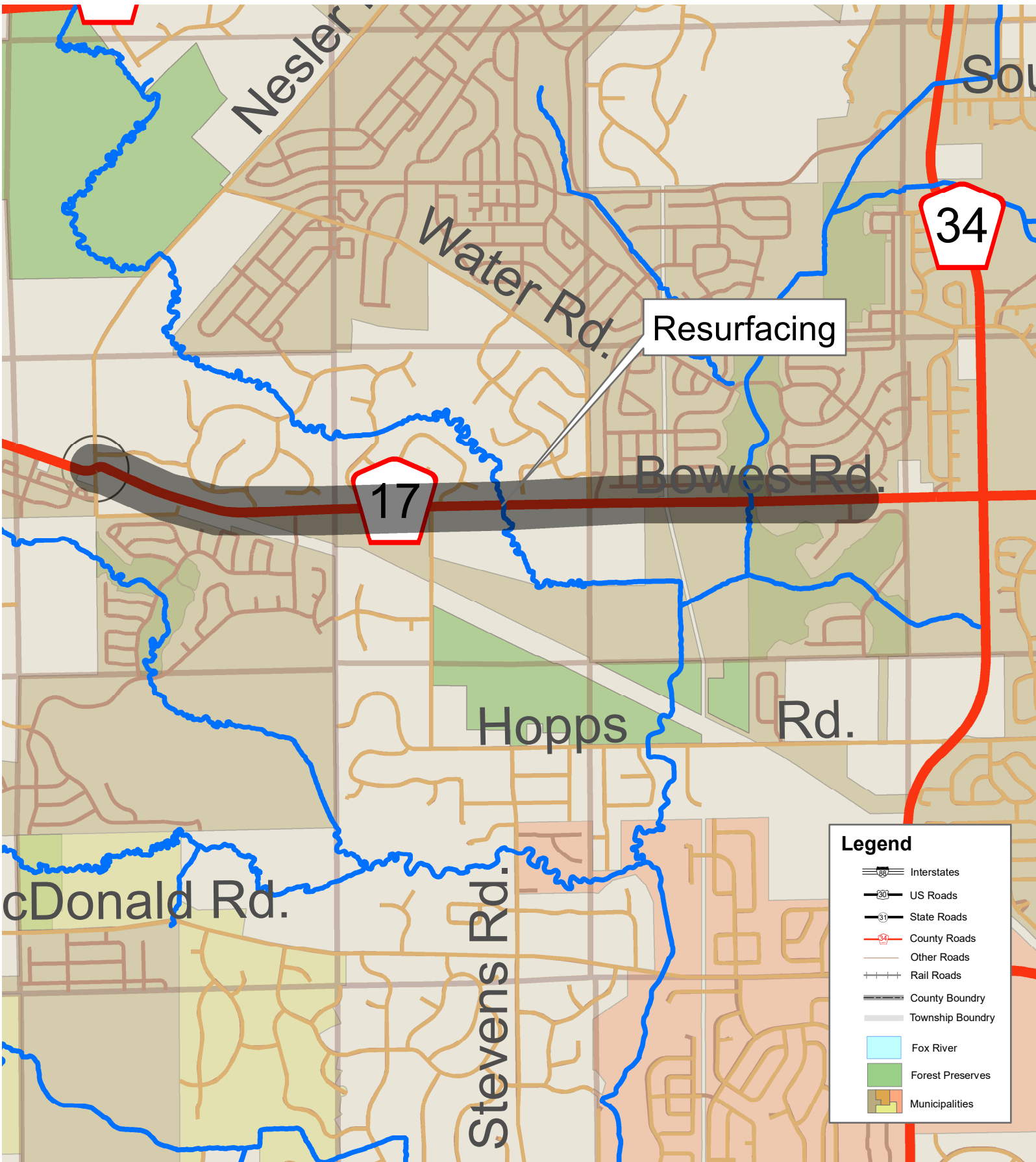

## Work Zone Safety Alert

Drivers in this project area should be prepared to reduce their speed, exercise caution, watch for construction workers and construction vehicles entering or leaving the site, and obey flaggers and other traffic control devices within the work zone. Drivers should expect delays and may want to add additional time to their commutes and consider the use of alternate routes while this work is completed. KDOT reminds drivers that it is illegal to talk on a cell phone or text while driving through a highway construction work zone. The minimum penalty for speeding in a work zone is \$375.
