Longmeadow Parkway Section D Advanced Tree Removal Kane County Section No. 16-00215-31-PV

Starting the week of January 22, 2018, weather permitting, right of way preparation and tree removal will begin along the Longmeadow Parkway Corridor from east of IL 25 to IL 62 and along IL 62 in the Village of Barrington Hills. During the work there may be temporary single lane closures with flaggers directing traffic. Construction work hours will be from **7:00 am until 5:00 pm Monday thru Saturday. This work is anticipated to take approximately two weeks to complete**, weather permitting.

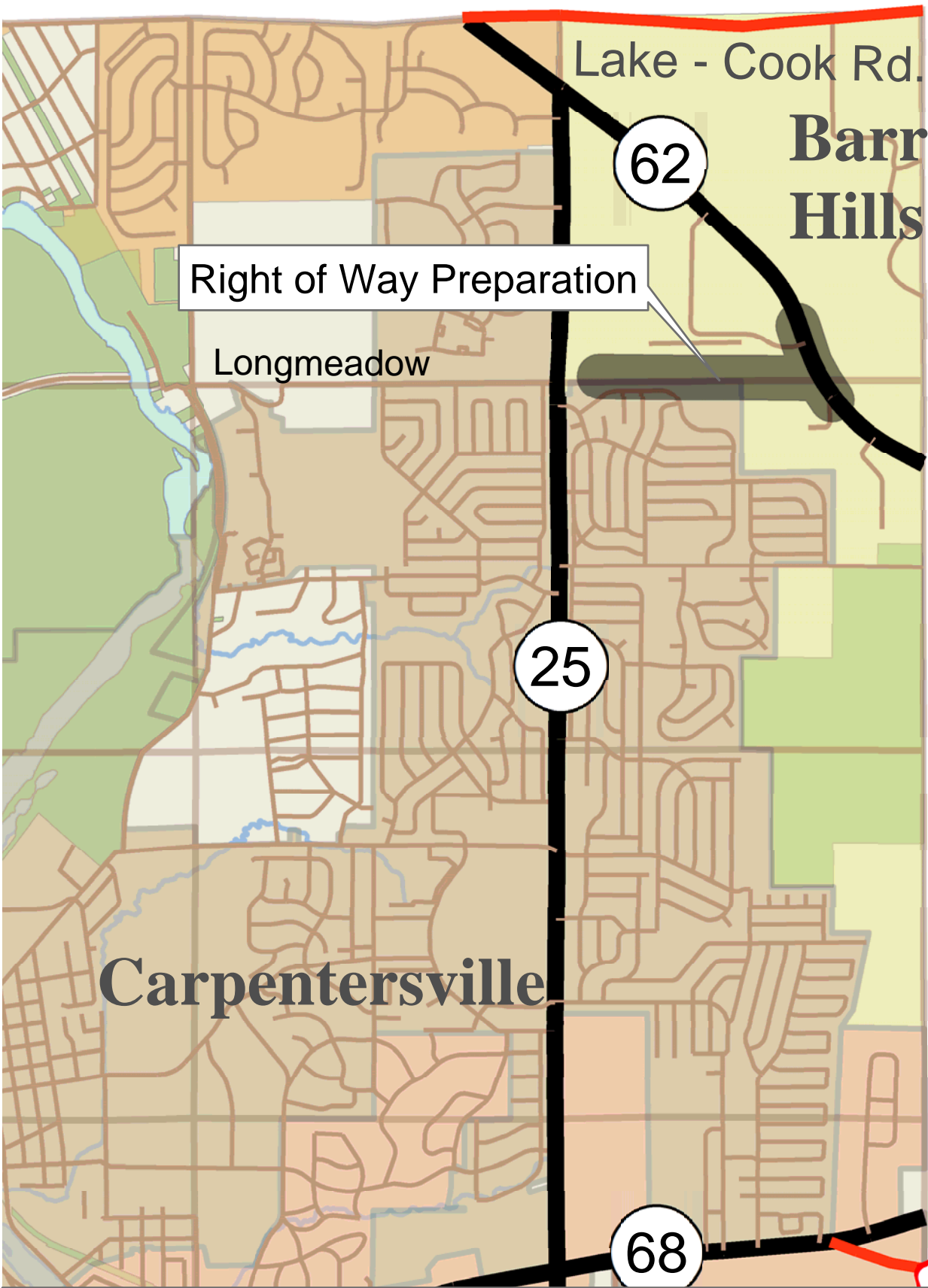

The work is being done in advance of the roadway improvements that will start in spring 2018.

The above-mentioned roads will remain open during treatment, but may be reduced to one lane of travel using temporary daily lane closures. Motorists need to be prepared to reduce their speed, exercise caution, and be extra alert. Motorists must watch for and obey flaggers and other traffic control devices within the work zone. Motorists should expect delays while traveling through the work areas. Motorists may want to add additional time to their commutes and consider the use of alternate routes while this work is being completed.

A reminder – it is illegal for drivers to talk on a cell phone while driving through a highway construction work zone.

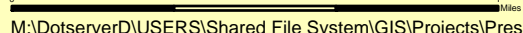
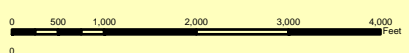
