If you are interested in giving input or looking at the Strategic Plan there is information on the RTA's website.

RTA staff gave an overview of the 2022 Regional Budget. Transit is slowly recovering from the pandemic. The fares are slowly recovering. Sales Tax revenue rebounded more quickly giving a more positive outlook of the upcoming budget. Each of the service boards projected operating expenses were reviewed. The status of the 3 Federal Relief Packages that have been released so far were also reviewed.

Next meeting of the RTA CAB is set for January 22,2022.

## Kane County/AID Transition

Forbes provided an overview of where things were at with the transition of Kane County assuming the role of administrator of the grants for Ride in Kane. Since the last meeting, the RTA and FTA have approved Kane County's application for 5310 funding for Phase 19 & 20. They also approved the transfer of the Phase 17 & 18 5310 funds and the remaining Phase 9 & 10 JARC funds from AID to Kane County. The various agreements with the RTA and Pace are going through the County approval process. It is a 2 month process and is going through now. Assuming everything will be approved and signed by the County Board by late December or January.

Kane County will continue to support all the sponsors through the Kane County subsidy that has been given in the past. There will be no change in that. Kane County will, however, research other potential funding sources for the program.

In January, Kane County is going to offer JARC rides for low income residents throughout the County as a sponsor. There has been discussions about how to roll this out. To start the process Kane County will utilize the JARC funds for low income residents throughout the county, not just those areas that are not currently served. If you have individuals that are low income that need rides to work, Kane County will register them. Kane County will complete the income verification process and will offer these types of rides until the JARC funds are expended. Current JARC rides will remain the same, but if you have individuals who are low income that you are currently not serving, you can have them contact Kane County. There is approximately \$800,000 in JARC funds left. This will be a slow roll out and rides for individuals with low income needing transportation to work will be the only type of rides Kane County will sponsor for now. Nothing should change for current sponsors.

Krystal Spracklen is now the Ride in Kane Program Coordinator. She will do all the work that AID used to do. She will be doing registrations for Kane County. She will be reviewing the registrations that the sponsors have. She will keep the master list up to date, answer questions for riders, work with the sponsors, provide reports to sponsors, work on the invoices. This is a full time position dedicated to Ride in Kane.

Kane County is creating a new Ride in Kane website. We are making updates and changes. Hope that it will be easier to navigate. The current website address will be automatically directed to the new website. The Rider's Guide will be updated and distributed. There is a new logo that is being used.

## Kane County/AID Transition cont.

The information line for Ride in Kane will now be 630-726-2600 beginning January 3rd.

Ride in Kane will be housed in the Kane County Division of Transportation building. Individuals will be able to drop in or schedule appointments to come in and fill out registrations or get materials.

Sponsor agreements are still being reviewed by Kane County's state's attorney. Once those are approved, Krystal will be sending the final version out to each of the sponsors for signatures.

At the beginning of December, there was a Kane County Connect article about the transition and also a press release went out. Unfortunately people can pick and choose what they post from a press release so there was some information left out and it was not clear that the program was not changing and that the only change was in the administration of the program from AID to Kane County. Also that Kane County is only going to offer rides for low-income, but nothing else in the program is going to change. Included in the packet is a copy of a letter that was sent out to certain townships and municipalities that are not sponsors right now to let them know that Kane County will be offering to sponsor rides for individuals who are low income to get to and from work. It also encouraged them to look into possibly becoming a sponsor.

It was clarified that the location is on Burlington Road. It was also clarified that the procedure for scheduling rides is the same. Once registered, a rider calls the Pace call center to schedule their rides. If they have issues or complaints they will call the complaint line at Pace. They can also contact Krystal at the 630-762-2600 number for other issues.

Ken Rojek from Big Rock Township stated that he was on a fact finding mission and to determine if Big Rock Township should once again join Ride in Kane next year. When they were a sponsor in the past, it was not too successful. He is hopeful with the transition over to Kane County that the program would once again work for them. Forbes, stated that over the past years there has been improvements, currently there are challenges due to driver shortages.

Robin Arsenault with the West Aurora school district transition program asked for an explanation of the JARC program. JARC stands for Job Access Reverse Commute. Funding for rides specifically for jobs and training. Spracklen went on to explain that the funding is to assist individuals in getting jobs and to get back and forth to work. This includes vocational training and rides for their children to get to and from school. Arsenault explained West Aurora has individuals that are low income. Spracklen indicated that the County could sponsor these individuals, but also if the individual has a disability and live in an area that already has a sponsor, they could register with their township or municipality and utilize both JARC and 5310 funds. Spracklen indicated that she and Robin can look at this case by case to determine the best fit for the individual.

### 5310 and JARC Budget Report:

Krystal Spracklen summarized the grant totals for JARC and 5310 funding and how long the funding in each phase will last. She reviewed the cost reports. Krystal asked that if sponsors review the data and see any discrepancies in their numbers to let her know since she has no way of verifying costs for January thru May. The Quarterly reports were reviewed. Krystal pulled all reports back to January 2021 so these numbers are accurate. Trip count is slowly increasing, but is still just barely over 1/2 of what the rides used to be before the pandemic. Trip Mileage mirrors the trips. Average trip remains around 5 miles. Program performance was reviewed. On-Time performance has been corrected now to reflect the 31 minute. Discussed the large drop off in July, not sure what happened. Discussed that late cancel/ no show, which is a rider issue, and missed trips, which is a provider issue, will be reported separately.

### 5310 and JARC Budget Report:

Krystal discussed the distinct riders and the registered riders. Registered riders is much harder to get the past numbers without going back and opening every registration to get the date. Going forward, this will be changed to show a row for current registered and a row for new registrations for that month. The data will begin to be reflected in November. It was explained that distinct riders is the actual number of different people that rode. For instance in July 441 different people took 4,332 trips.

### Registration and Ridership Reports and Customer Complaint Records:

Kisha Hearn introduced Gary Scott who stepped in on October 14th as the interim project manager for the Ride in Kane program. She thanked Krystal and Jackie for their patience. Sponsors can reach out to Gary for any questions or concerns. If Gary is not available, you can reach out to Kisha Hearn or Rosemary Gerty. Gary referred to the July, August, and September Ridership growth reports, Productivity Data report, and OTP report and led a discussion. The number of trips per month increased each month. He indicated that productivity is increasing because multiple riders can ride again instead of just one person per vehicle. Gary noted the on time performance by month and type of ride. Gary went on to discuss that on October 8, 2021 Pace began to do trip prioritization for medical, work, and school trips. The call taker will work with the caller to schedule other types of rides to schedule in less busy times. He feels this is helping with the Ride in Kane program. They are still facing a severe driver shortage for both bus and taxi. Gary will provide openings on the weekly report. Aurora is in need of a driver. There is currently a sign on bonus of \$2,000 with MV Transportation.

Gary reviewed the complaint and accommodations report for each month (July— September) The breakdown is noted by sponsor by month. Late arrivals was the highest complaint area each month. He emphasized that these are complaints that are actually called in to the customer service number and do not include complaints that were addressed to him. In September the number of complaints did go down. In July, Aurora Township had the most complaints. The initials of the complainant are reversed. In August, City of Elgin had the most complaints. September had less complaints. Gary encouraged the sponsors to reach out to him with questions or issues. He provided his contact information in the chat. E-mail: gary.scott@pacebus.com. Phone: 312-341-8067. Jackie thanked Gary for all that he has done for Krystal and herself. Gary was asked when the August—October invoices would be received. Gary stated that they were still working on August. Kisha responded that August and September should come out by the end of December. October should be sent out at the beginning of January. Then everything should be back on track. Growing pains with Taylor leaving without much notice, but now everything should be changed over and be smoother from here on.

### **RTA Updates:**

Linda Chamberlain informed the sponsors that the mobility management team is continuing with virtual presentations and attend outreach events virtually. Travel training program remains on hold, however the team is working on developing a hybrid training on-line. This may be available as early as January. The ride free and reduced cards were autorenewing, but as of January 1, 2022 that will no longer be the case. Riders will need to apply to renew their cards now. RTA has an on-line portal that will be starting with the new year. People will now be able to fill out the application for free and reduced cards on-line. It is called the RTA Fare Program Online.
